## Terms and conditions of Advance Registration

- 1. That company shall intimate me about the availability of Residential apartment within 12 months of my registration application made herein.
- 2 That Applicant shall submit an application on prescribed format of the Company for allotment of residential apartment within a month from the date of such intimation.
- 3 That the above said advance registration amount paid by me would be adjusted/appropriated against the amount payable by me in future pursuant to your intimation for availability of Residential apartment.
- 4 That in the event of said intimation for a Residential apartment is made to me after 12 months, compensation @ 7.5% p.a. shall be paid to me for the period beyond 6 months from date the amount paid by me up to the date of said intimation.
- 5 That in the event of said intimation for a Residential apartment is not made to me within 12 months from the date of my application, than we shall have the right to withdraw my request before the intimation for a Residential apartment is made to me and ask for refund by giving 30 days notice along with compensation calculated @7.5% p.a. for the period beyond 6 months from the date of application.

- 6 In case the Applicant wishes to withdraw the application prior to 12 months, 50% of the advance registration amount will be forfeited.
- 7. The Applicant(s) understands and agrees that in case the full / complete booking amount is not received by the company, the provisional booking made shall be treated as invalid and cancelled and the company shall refund the partial booking amount received to the Applicant(s) without any interest after deducting the processing fee of Rs.25,000/-.The Applicant(s) agrees and undertakes that he shall not raise any claim, objection , protest or demur against the cancellation of the Application for provisional booking / registration of the Residential unit.
